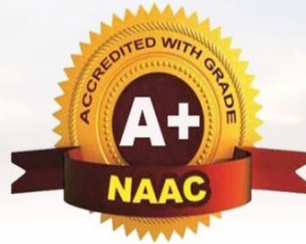




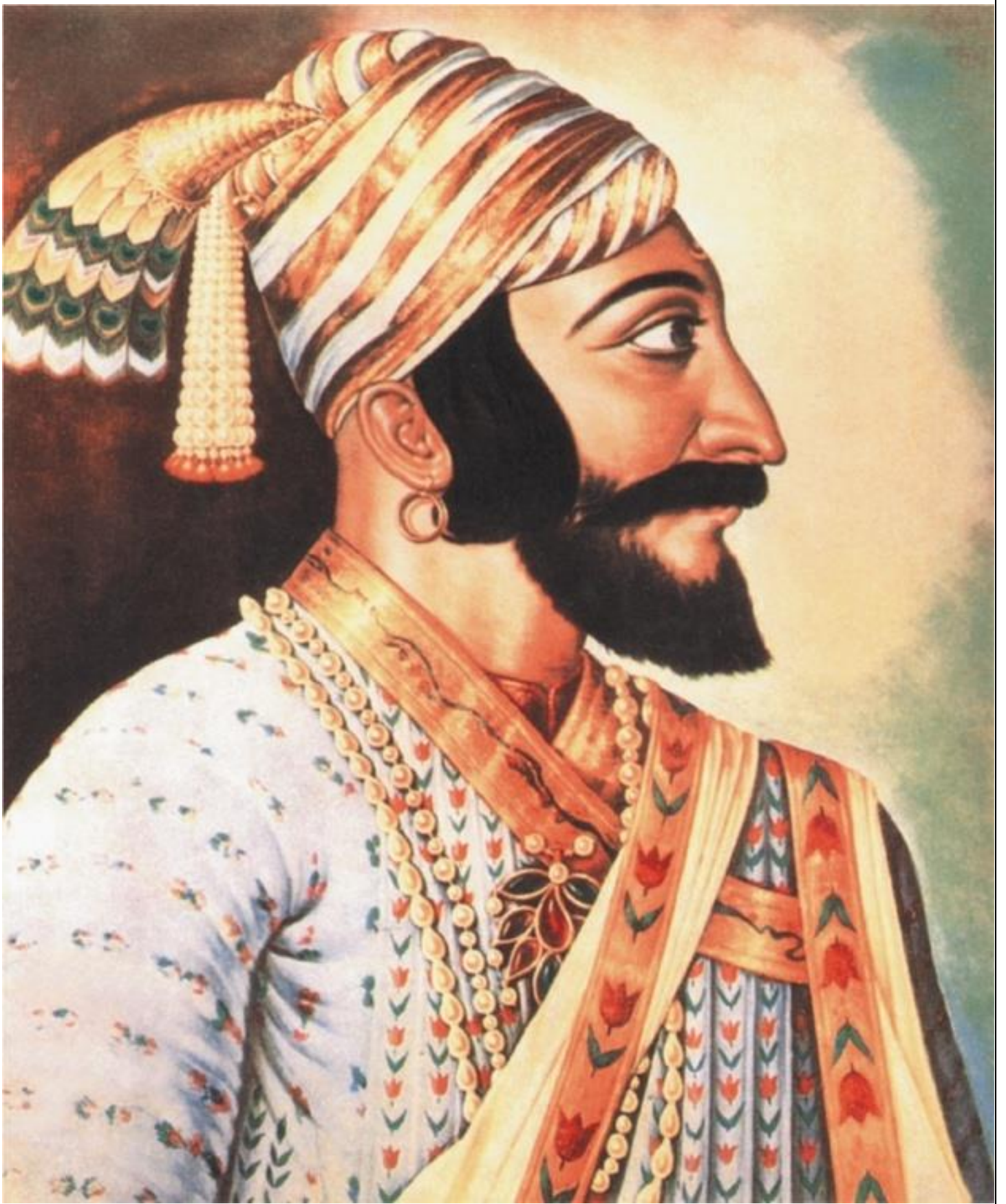

BRIEF HISTORY OF INSTITUTION

Our parental institution was established in 1943, by Late Karmaveer Dr. Mamashebjagdale as Shri Shivaji Maratha Boarding and renamed as **Shri Shivaji Shikshan Prasarak Mandal's Barshi** in 1946. The sanstha aims at imparting liberal and vocational education up to the University level. Embossing Social, Cultural, Scientific, Medical, Agricultural, Commercial, Legal, Industrial, Education & Physical Education to the rising generation of India in general, Maharashtra in particular, irrespective of Caste Creed, gender, religion. **“Let us help one another and March on a righteous path”. is our Motto.** At present the Sanstha runs Eight Colleges, Fourteen High-Schools, Four Primary Schools, Two Pre-Primary Schools, Two Boardings, One well equipped Hospital with 300 Beds.

Rajarshi Shahu Evening Law College, Barshi, was established in 1972 with the permission/approval of the Govt. of Maharashtra. It is recognized by the Bar Council of India, New Delhi. The college was first affiliated to Shivaji University, Kolhapur and thereafter it was affiliated to Solapur University, Solapur from the Academic year 2004-05. The college has been imparting quality legal education through its LL.B program since its establishment, it content integrated BA.LL.B course in the academic year 1999-2000 and has further expanded its academic offering by commencing the LL.M program from the academic year 2025-26, all in accordance with norms prescribed by the Bar Council of India and the affiliating university.

The college has been assessed by **the NAAC, Bangalore in January, 2024 and accredited with A+ Grade Institutional CGPA 3.29.**

OBJECT:-

The college was established with an objective to increase legal awareness and impart quality based legal education in Barshi and neighboring areas.

The college aims at producing competent professional law graduates by training students skills like communication, legal writing, argumentative skill, analytical ability and skill for decision making which are strongly needed for the legal profession.

COURSES OFFERED

The Law Degree Courses are as under:-

1. LLB. (Three Years Course):-

This course is of three years' LL.B. degree will be awarded after passing the Three Years LL.B. examinations conducted by the University.

2. Five Year B.A.LL.B Integrated Course:-

This course is of five years duration. The students admitted to this course will be awarded B.A.LL.B Degree after passing the 5 years LL.B. Examination conducted by the university.

To be a law practitioner, the Degree of LL.B. is a must. The Student completing Third Year LL.B. Fifth year B.A.LL.B. can obtain a “SANAD” from the state Bar Council and is entitled to practice within the state or anywhere in India's respectively after passing BAR Council of India's Examination.

3. LL.M (Master Of Laws):-

This course is of 2 year duration. The student admitted to this course will be awarded LL.M (Master of Law) post graduate degree after passing the examination conducted by the university. The LL.M degree is essential for those aspiring to pursue a career in legal, academic, Research or higher Judicial Services, as it provide advanced knowledge of legal principles, fosters specialization and fulfill eligibility criteria for law teacher and competitive examination such as the SET, NET and Judicial services.



RULES RELATING TO ADMISSION

A) Eligibility for admission to 3 year LL.B. Course :-

1. **1st Semester:** - For Admission to the 1st Semester of 3 year LL.B. Course, a student must have passed Bachelor's Degree Examination in any Faculty of a recognized University with minimum 45% of marks (including Grace Marks) at the qualifying examination. However the above percentage of marks will be 40% for the students belonging to SC/ ST categories. Admission will be given in accordance with the Merit in MAH-CET examination.
2. **2nd , 4th and 6th Semester :-** A student for being eligible for admission to the 2nd, 4th and 6th Semester must have successfully kept the terms for the 1st, 3rd, 5th Semester respectively irrespective of the result of these Semester examinations.
3. **3rd Semester:** - A student for being eligible for admission to the 3rd Semester must have either passed in the 1st and 2nd Semester or must have got exemption in at least seven papers of the 1st& 2nd Semester.
4. **5th Semester:** - A student being eligible for admission to the 5th Semester must have either passed in the 3rd and 4th the Semester or must have got exemption in at least six papers of the 3rd&4th Semester.

B) Eligibility for Admission to 5 year B.A.LL.B. Course :-

1. **1st Semester:** - For Admission to the 1st Semester of Five years B.A.LL.B. Degree Course, a student must have passed H.S.C. Examination (10+2 pattern) or equivalent qualification with minimum 45 % of marks at the qualifying examination. However the above percentage of marks will be 40% for the student belonging to SC/ ST categories. Admission will be given in accordance with merit in MAH CET- 2018-19 examination.
2. **2nd, 4th and 6th 8th and 10th Semester:** - A student being eligible for admission to the 2nd, 4th, 6th, 8th and 10th semester must have successfully kept the terms for the 1st, 3rd, 5th, 7th and 9th semester respectively, irrespective of the result of these Semester examinations.
3. **3rd Semester:** - A student for being eligible for admission to the 3rd Semester must have either passed in the 1st and 2nd Semester or must have got exemption in at least Four Papers of the 1st& 2nd Semester.
4. **5th Semester:** - A student being eligible for admission to the 5th semester must have either passed in the 3rd and 4th semester or must have got exemption in at least four papers of the 3rd& 4th Semester.
5. **7th Semester:** - A student being eligible for admission to the 7th semester must have either passed in the 5th and 6th semester or must have got exemption in at least six papers of the 5th& 6th semester.

6. **9th Semester:** - A student being eligible for admission to the 9th semester must have either passed in the 7th & 8th semester or must have got exemption in at least six papers of 7th & 8th Semester.

UGC & University has been mandated to complete the Degree under N+2 Rule. The students are required to complete their degree course under the UGC & university N+ 2 rules (It means course duration plus additional two years) **Failure of which the admission of students will be automatically cancelled by the university.**

C) Eligibility for Admission to LL.M. Course :-

The candidate must have passed

1. Graduation in law (Five years law course or three year law course)
2. The degree must be from a University or Institution recognized by the Bar Council of India (BCI)
3. Minimum marks required
General category: - 50% marks in aggregate
SC/ST/OBC/EWS/Other – as 45% marks or (as per prevailing State Government / University Rules).
4. Must have appear CET conducted by the affiliated University

Duration of program

The LL.M program shall be of two year consisting four semester respectively in line with UGC and Bar Council of India norms

Intake capacity

The number of seats available for LL.M program shall be as per the sanctioned intake approved by the university and Bar Council of India.

Reservation policy

Reservation in admission shall be provided as per the state govt. and P.A.H. Solapur University regulation applicable at the time of admission.

Medium of institution

The medium of instruction and examination shall be English, unless otherwise notified by the P.A.H. Solapur University

Admission process

Admission may be conducted through

- Entrance examination conducted by P.A.H. Solapur university.

Attendance- All the student must maintain minimum 75% attendance in each subject (Theory and practical) through Biometric, LMS or other Approved mode. The student with less than 75% attendance will not be allowed to fill the exam form and appearing in the university examination.

RULES RELATING TO SEMESTER – SYSTEM

LL.B. Three Year & B.A.LLB. Five Year Law Course.

1. The Three Year LL.B. Degree Course shall be of Six Semester Full Time Course leading to LL.B. Degree. The integrated Five Year B.A.LLB Degree.
2. No candidate will be admitted to the Semester Examination unless he has 75% attendance in lectures delivered in the given Semester in each Subject.
3. There shall be an examination at the end of each semester.
4. For CBCS pattern each Theory paper of each semester will carry 80 marks and will be of Two & half hours duration. & 20 marks for continuous assessments as per internal evaluation.
5. No students shall be allowed to simultaneously register for a law degree program with any other graduate or postgraduate course run by the same or any other university or institute for academic or professional learning.

6. Internship :-

- A) Each registered student shall have to complete minimum of 12 weeks internship for Three Year LL.B. Degree Course stream and 20 weeks in case of Five Year Integrated B.A.LLB. Course stream during the entire period of Legal studies under NGO, Trial and Appellate Advocates, Judiciary, Law firms, Companies, Local Self Government. Provided that Internship in any year cannot be for a continuous period of more than Four Weeks and all Students shall at least have gone through once in the entire academic period with Trial and Appellate Advocates.
 - B) Each student shall keep an internship Diary to be evaluated by the guide in Internship and Core Faculty members of the Staff each time. The total marks shall be assessed in the final Semester in Moot Court Exercise and Internship Course.
7. The Student shall write a prescribed number of tutorials / Assignments /Case Comment /Project Report.
 8. The Student shall appear and attend academic discussions/ Debates / Seminars.
 9. The Student shall have to appear for the midterm or other Examinations of the college.
 10. The Student shall attend prescribed practical training programs including Legal Aid Clinic, Lok Adalat, court visits, moot courts, office visits & internship programs etc.

11. Standard of Passing:

A) FOR CBCS Pattern

1. From Academic year 2023-24 students who have been admitted in LLB-I (3 year course) B.A.LLB. –I (5 year law courses), candidate may be Exempted from appearing in paper or paper of each semester in which he has secured not less than 40% marks.
2. A candidate shall be declared to have passed in the semester examination if he has obtained not less than 40 marks (32 external University, 8 in internal examination) in each paper & not less than an aggregate of 50% of Marks in all the papers of Semester examination. This rule is applicable for students admitted up to academic year 2022-23.

3. A Candidate may be exempted from appearing in paper or papers of each semester in which he has secured not less than 50% marks. This rule is applicable for students admitted up to academic year 2022-23.
4. A student who failed in University semester examination (Theory) and passed an internal examination of paper (subject) shall be given FC Grade. Such students will have to appear for the term end examination only. A student who failed in internal examination and passed in University Examination (Theory) shall be given FR Grade. Such students will have to appear for term end examination as well as internal examination.
12. All the semester Examinations will be conducted twice in a year i.e. October/ November and March/ April.
13. The LL.B and B.A.LL.B. Degree will not be conferred upon a candidate unless the candidate has passed in all the papers prescribed for each semester Examination.
14. The College may be allowed to admit students for the entire academic Year i.e. for both the semester during the Academic year at one time.
15. To pass any of the semesters Examination, a student must have passed all the papers of that semester.
16. The results of the candidate appearing at 4th, 6th, 8th, and 10th semester of Five Year Integrated B.A.LL.B Degree Course shall not be declared unless and until the candidate has been declared 'Pass' in all the papers up to 2nd, 4th, 6th and 8th semester respectively.
17. The result of the candidate appearing at the 2nd, 4th and 6th semester of three year LL.B. Degree Course shall not be declared unless and until the candidate has been declared 'Pass' in all the papers up to 2nd and 4th semester respectively.

18. Rules of promotion/ATKT for LL.M: -

LL.M course to promote a student in 3rd semester. a student is being eligible for admission to the 3rd semester must have either passed in the 1st and 2nd semester or must have got exemption in at least six papers of the 1st and 2nd semester and all other rules prescribed by the affiliating University

RULES OF DISCIPLINE

(To be followed by Students)

1. The students must maintain silence. They must not loiter in the passage corridors during lectures. They must read quietly in the library and spend their spare time in such a way that it should not cause any interference with the work of others. Absolute silence must invariably be preserved in the library as well as in the classrooms. Anybody found guilty of breach of this rule will be severely dealt with.
2. A student enrolled in this college to any law course must attend 75 percent of the total. Lectures delivered in the academic year according to the rules of the Bar Council of India. If he fails to keep minimum attendance required, his examination form will not be forwarded to the university.
3. Students are required to attend functions celebrating Days of National Importance.
4. It shall be binding on the part of the students to see that no damage is done to the property of the college in any manner.
5. The students shall behave with their classmates, teachers' authorities and the non-teaching employees of the college in a responsible manner.
6. The Students involved in any attempts of common offs, vulgarism, gundaism, man-handling, eve-teasing, malpractices or participation in criminal acts shall be liable for punishment.
7. Mobile phones should be switched off or kept in silent mode in the Library, class rooms & in the office.
8. No candidate will be allowed to appear at the Third Year LL.B. examination of the three year law course and fifth year examination of the five years law course unless he has completed his tutorial work & Internal Examinations.
9. No society or association of the students of the college will be permitted to be formed without the prior permission of the Principal.
- 10.No meeting or other activity shall be allowed in the college without the prior permission of the Principal.
- 11.No person shall be invited to address the college students or the members of any Students society without prior permission of the Principal.
- 12.All Subjects of debates or items of entertainment in the college are to be approved by the Principal.
- 13.Students should not indulge in malpractice during internal tests & not to be absent from internal Examinations.
- 14.Students should follow the dress code in the college as prescribed by the Principal.

- ii) Asking a student to do any act or perform something which such student will not, in the ordinary course, willingly do.

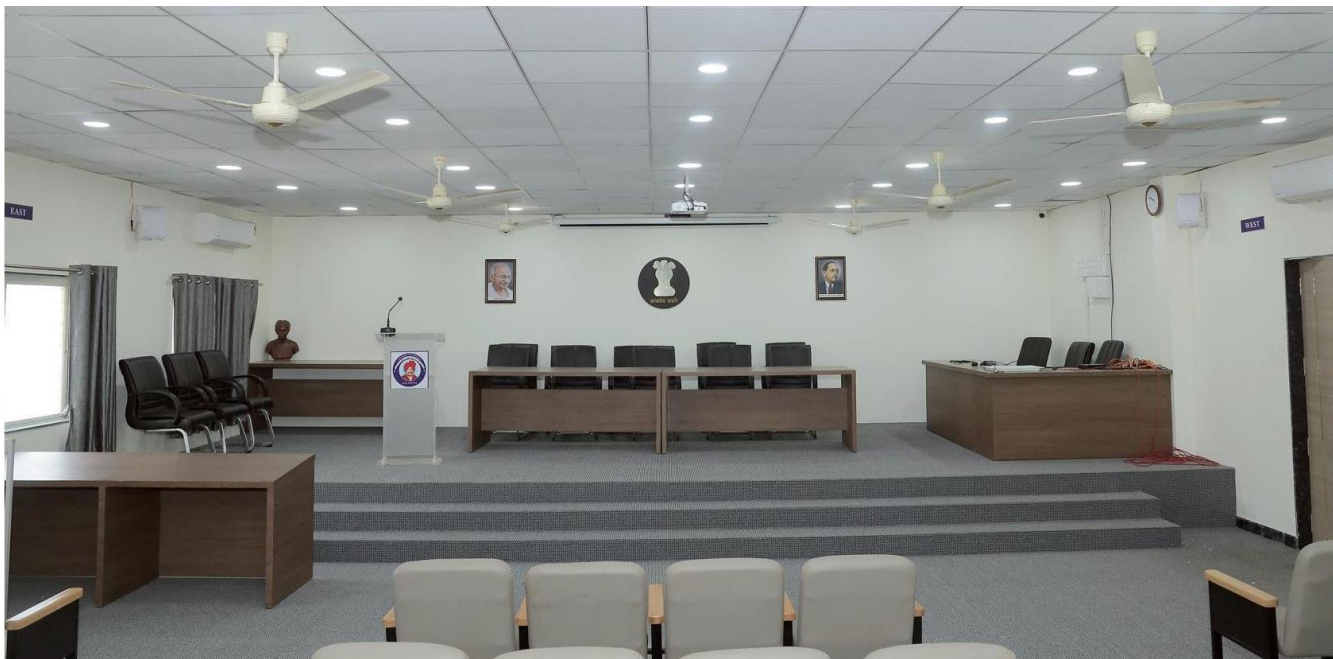

5. **Moot Court:-**

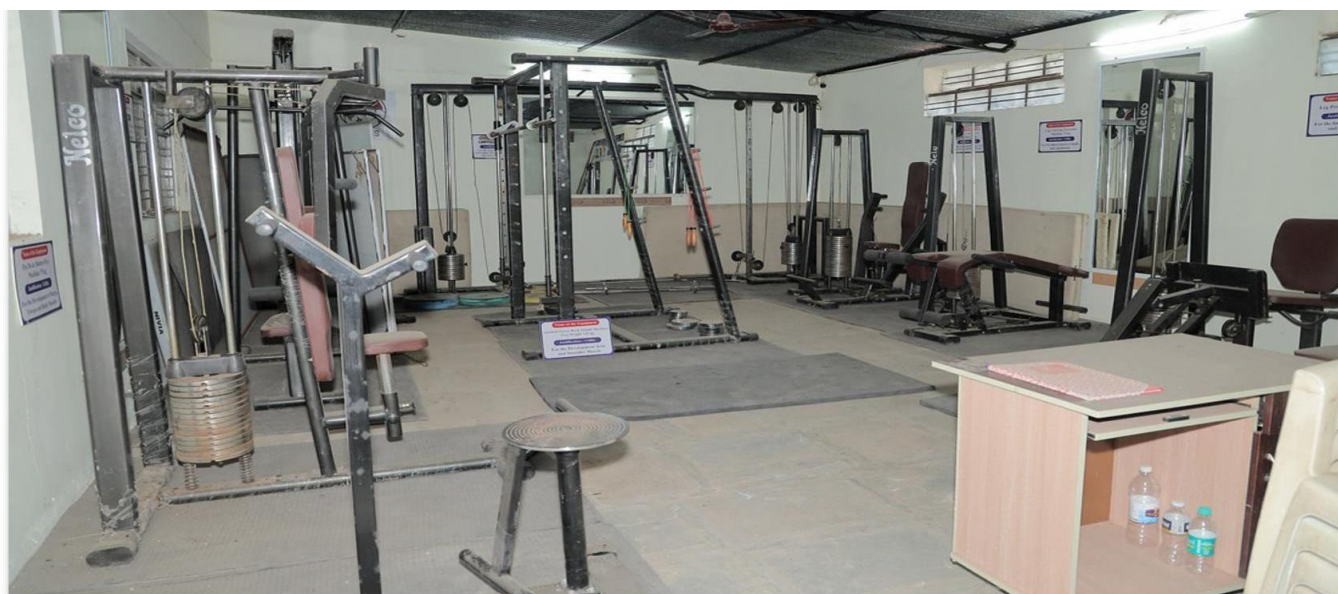
