To see the functioning of a police station. To see how a FIR is lodged. The role of police in contemporary society.

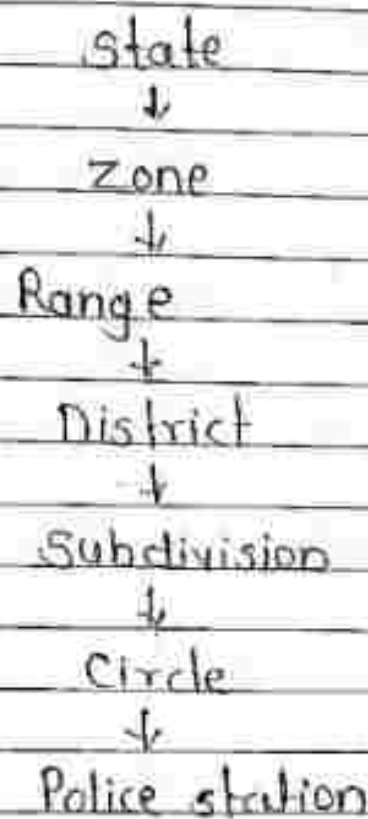
Introduction

The necessity to maintain peace and keeping law and order in the society led to the establishment of law enforcing agency in the form of Police. The word 'police' is derived from a Latin word 'politia' which stands for state of administration.

The police station in Barshi works for 59 villages. There are total 60 police in worked in Gramin Police station, 52 main & 8 Senior police officers. The police is undertaking the following activities:-

- * Preventing the Crime
- * Controlling Criminal activities
- * Arresting the anti-social elements
- * Maintenance of law and order
- * Maintaining peace and tranquillity
- * Woman protection
- * Controlling traffic.

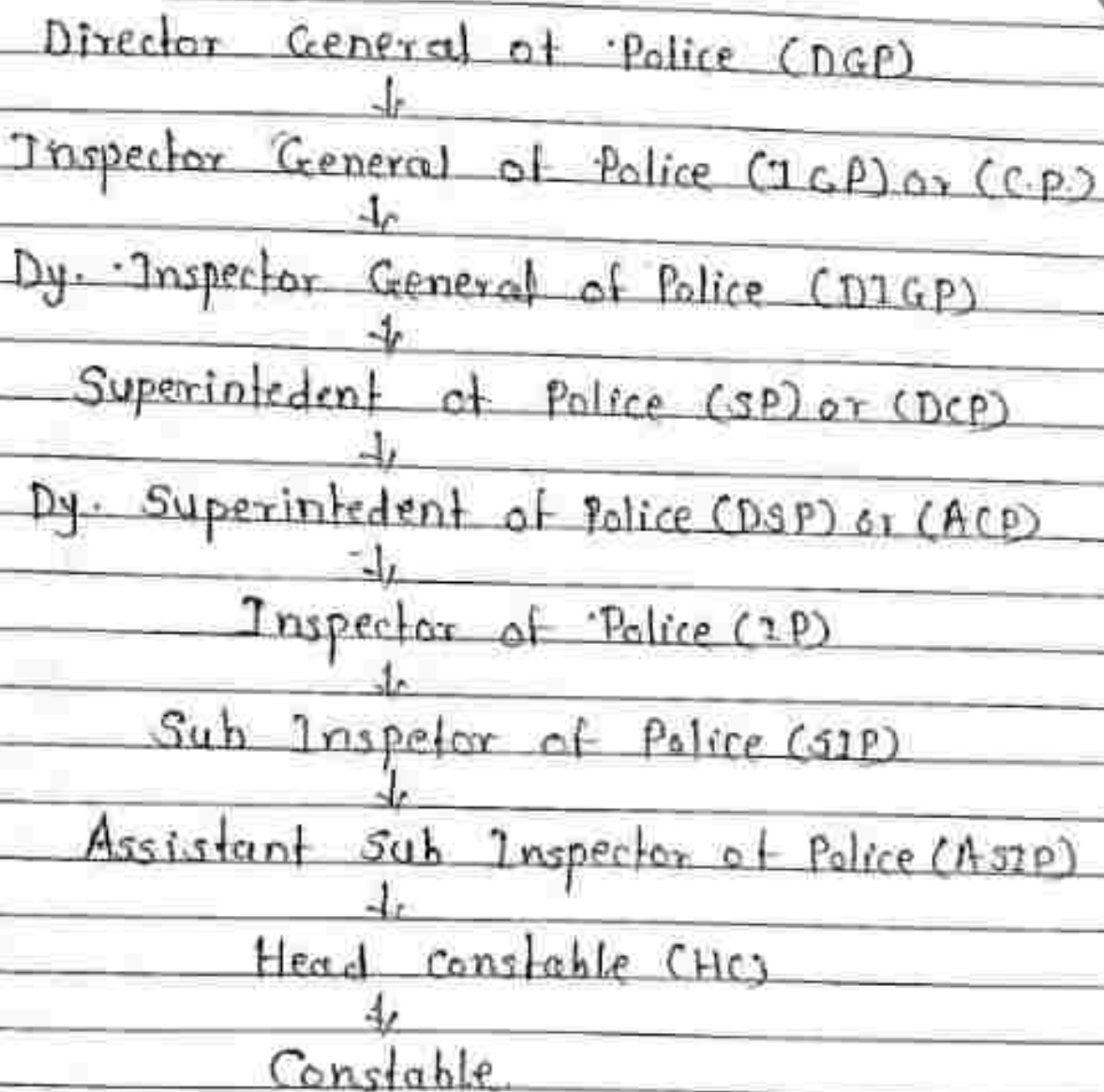
Division of a state



An officer at rank of SP heads the district police force. A group of districts forms the range, which is looked by an officer of the rank of DIG police. Some states have zones comprising of two or more ranges under the charge of an officer of the rank of IG police.

Each district is divided into sub division. Sub division is under the rank ASP/DSP. Every division is further divided into no. of Police stations.

Organisation Setup of Police



Director General of police is the head of the police department. He saw all the management of police & Inspector general is 2nd highest post. There is more than one Inspector general under the director general. After that the another posts of police comes.

Physical Observation

As we entered the gate of police station, we found the ground floor consisted of following section:-

1] Reception:- On the left hand as we entered the gate inside the station there was a reception which consisted of a big wooden table. It was headed by a lady constable. It is a place from where the complaint is directed to the respective duty officers.

2] Duty officer:- Duty officer is a person who lodges the FIR & tells the respective officer about the report. He maintains the daily diary & puts entry in them.

3] Investigation room:- There is a room in the police station where a person whether accused or witness can be detained for some time by the investigation officer for enquiring.

4] Record room:- All files are maintained here. The record of various offences & their details. PCR call record, bail register, FIR Record & other information are maintained here.

5] Police Maalkhana:- It is one of the most important parts of a police station. This room is a place where the various types of items collected for e.g. cloths, weapons etc. collected from the place of crime.

6] Computer room:- The FTR is now recorded in computerized form after the year of 2007. And all the data of police station saved on his website.

7] Police lock up:- There are separate lock-ups for male & female. It is two in number. A proper sanitation facility is there.

Preparation of case Diary U/s 172 Cr.P.C.

Case diary is also called as C.D. which contains all the investigating details. It has two kinds of pages as inner case diary & outer case diary. These diaries are a relevant part of the case file which has F.T.R.

Personal Observation

It was observed from the visit that it is kind of sub-rural area & literacy of the localities is very low. It might be a reason for cases that are coming there which is related to theft, neighborhood clashes, pick-pocketing, cheating, juveniles in conflict with law. On the other hand the types of crime mostly family disputes, husband-wife dispute, vehicle theft, house trespassing etc.

The police station has now become advanced as compared to earlier. All the data of police record are now saved in computers instead of managing it in files and papers.

In this visit of police station we understood the basic structure of police station. There are some Help-line No. of some senior officers in the reception & there is a notice board in which the daily notice is written for the officers.

What is Lok-Adalat?

Lok-Adalat is a statutory organization under the Legal Services Authorities Act, 1987 and was created as an alternative dispute resolution mechanism used in India to resolve disputes/grievances outside courts. It is a forum where cases pending on panchayat or at a pre-litigation stage in a court of law are settled. Under this act, the award (decision) made by the Lok-Adalat is deemed to be a civil court case and is final and binding on all parties. No appeal against such an award lies before any court of law. If the parties are not satisfied with the award of the Lok-Adalat [though there is no provision for an appeal against such an award], they are free to initiate litigation by approaching the court of appropriate jurisdiction.

What is Legal Volunteers?

During the year 2009, National Legal Services Authority (NALSA) brought out a scheme called the Para-legal Volunteer scheme which aimed at imparting legal training to volunteers selected from different walks of life so as to ensure legal aid reaching all sections of people through the process of para-legal volunteers scheme ultimately removing the barriers into access to justice.

Ultimately the process aims at legal services institutions reaching out to the people at their doorsteps rather than people approaching such legal services institutions.

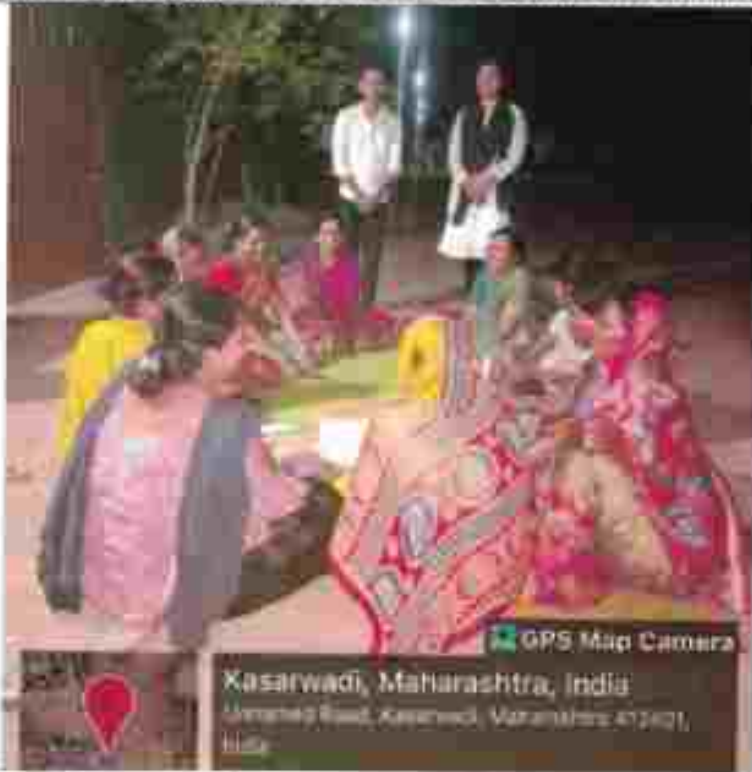
