**Preamble:-** Government has implemented recommendations of University Grants Commission of 7<sup>th</sup> pay commission as well as minimum qualifications for appointment in respect of teachers in Non Agricultural Universities and affiliated colleges vide Government Resolution dated 8<sup>th</sup> March, 2019. University Grants Commission vide its notifications dated 30.06.2023 and 31.07.2023 has made amendments in minimum qualifications for appointments of teachers in Universities and affiliated colleges. It was under consideration of the Government to implement these amendments in respect of teachers in non agricultural Universities and affiliated colleges. Accordingly following amendments and additions are being issued.



**Resolution:-**

1. "NET/SET/SLET shall be the minimum criteria for the direct recruitment to the post of Assistant Professor for all Higher Education Institutions"

विद्यापीठ अनुदान आयोगाने दिनांक ३०.०६.२०२३ आणि ३१.०७.२०२३ च्या अधिसूचनांद्वारे विद्यापीठे आणि संलग्नित महाविद्यालयांमधील अध्यापकीय पदांवर नियुक्तीच्या अर्हतांमध्ये बदल केले आहेत. सदर बदल समक्रमांकाच्या दिनांक ५ मार्च, २०२४ च्या शासन निर्णयान्वये राज्यातील शैक्षणिक संस्थांना लागू करण्यात आले आहेत. उक्त दिनांक ५ मार्च, २०२४ च्या शासन निर्णयातील, कोष्टकामधील अनुक्रमांक ३ अन्वये, कॅस अंतर्गत पदोन्नती मिळण्यासाठी आवश्यक असलेले उद्बोधन वर्ग (Orientation Course (OC)/Refresher Course (RC)) पूर्ण करण्यास दिनांक ३१ डिसेंबर, २०२३ पर्यंत मुदतवाढ देण्यात आली आहे. तथापि, त्यासाठी Precautions should be taken to not to give promotions with retrospective effect any case, अशी अट देखील टाकण्यात आली होती. सदर अटीमुळे अध्यापकांना कॅस अंतर्गत पदोन्नती मिळण्यास बाधा निर्माण झाली होती. यास्तव, सदर अट वगळण्याची बाब शासनाच्या विचाराधीन होती. त्यासंदर्भात खालीलप्रमाणे निर्णय घेण्यात आला आहे.
